OUR LAWSUITS CHALLENGE ENTRENCHED STEREOTYPES AND PROMOTE EQUAL OPPORTUNITY. THE ORGANIZATION SEEKS TO WORK WITH THOSE WHO HAVE THE LEAST ACCESS TO JUSTICE AND WHOSE STORIES NEED TO BE TOLD.
