- Demonstrated ability to produce press releases, messaging documents, op-eds, blog posts, graphics, documentaries, podcasts, and other content.
- Demonstrated understanding of intersectionality.

- Ability to translate “lawyer speak” and legal jargon for a non-lawyer audience, and an ability to translate policy issues for general audiences.
- Excellent written, verbal, and digital communication skills, including the ability to write for different audiences, including policymakers, traditional and alternative media, grantmakers, and advocates.
- Experience with rapid response communications, crisis management, or combatting disinformation.
- Demonstrated time-management skills; highly organized, with exceptional attention to detail.
- High level of skill towards cross-organizational collaboration and communications.
- Ability to work collaboratively with staff and partners to get the information, input, and perspective necessary to produce quality work.
- Commitment to our mission and values, which include racial, social, and economic justice, in addition to gender justice.
